

## **American Rescue Plan Student Aid Quarterly Report**

Report regarding Grays Harbor College participation in Section 2003(a)(1) of the Higher Education Emergency Relief Fund III (HEERF III), American Rescue Plan (ARP) Fund Reporting – Student Aid Portion to Public and Nonprofit Institutions for fiscal quarter three (July 1 – September 30, 2021).

1. Grays Harbor College (GHC) signed and returned a Certification & Agreement with the Department of Education to accept allocated funds for the American Rescue Plan (ARP), Public Law 117-2. The ARP established and funded the Higher Education Emergency Relief Fund III (HEERF III) to provide emergency financial aid and grants. These critical funds will help eligible GHC students cover expenses related to any component of the student's cost of attendance or for emergency costs that arise due to coronavirus.
2. Grays Harbor College received \$2,468,676 from the Department of Education and the American Rescue Plan.
3. As of September 30, 2021 Grays Harbor College distributed \$0.00 of the American Rescue Plan Aid.
4. Grays Harbor College estimates that 1,488 students at the institution are eligible to participate in this program and thus eligible to receive emergency funds to students under Section 2003(a)(1) of HEERF III, ARP.
5. As of September 30, 2021 Grays Harbor College has awarded American Rescue Plan Aid to 0 students under Section 2003(a)(1) of HEERF III, ARP.
6. Grays Harbor College uses a tiered funding model to determine distribution of emergency student aid, with larger awards being distributed to students who have an expected family contribution (EFC) of less than \$6,000 or students who receive a low-income tuition waiver for running start or transitions. Student must also have been enrolled at some point during the applicable academic quarter.
7. Instructions about student aid award notifications will be emailed to eligible students.
